The Conviction Integrity Unit recently visited the Imam at the Penitentiary in Tucson. Certain details have been made scarce, however, during the visit, government agents accompanied the unit to make an offer to the Imam. The offer was, give them information, and they would let the Imam go. His reply was that he was gone awhile, so he had no information for them.

LET THE MOVEMENT GO FORTH

The New Darul Islam Movement has gone international and is now in Africa. Coming in 2023, the Movement once again sponsors the Riyadhah, this time to be in New York right after Eidul Adha. BIG JOHN'S KILLER GETS TRIAL MOVED TO 2023



In November of 2019, Big John Williams, the Sheriff of Lowndes County, Alabama, was killed by a single bullet to the face. Big John was known for his protection of Imam Jamil during his arrest. He had also been a supporter of the Imam's project in Whitehall of building an Islamic city for which the Imam had been invited by the Mayor of Whitehall and other officials. With the Atlanta's Conviction Integrity Unit reviewing the Imam's case, Big John could have been one of the witnesses that they might have called upon, and Allah knows best.



The triggerman, William Chase Johnson, son of a Montgomery County Sheriff's Office deputy, had a trial originally set for Oct, 2022. However an order came that moved the trial date to Oct, 2023.

POLITICAL PRISONER REPORT

Imam Jamil's health is stable and is working out when possible. Despite artificial conditions, he never complains or talks much about it. He always says "Allah knows best. Everything is as Allah Wills."

In September, the Foreign Office during a hearing at the High Court in Islamabad, Pakistan, suggested renewing the efforts for Dr Afia Siddiqui's release on the diplomatic front.

Also in September, a new compassionate release request to the BOP was submitted for Dr Mutulu Shakur. A parole hearing was set for October 10th.

On October 26, 2022, a proposed order denying Mumia Abu-Jamal's constitutional claims of jury bias and suppressed evidence was issued by Common Pleas court Judge Lucretia Clemons. Mumia's defense included newly discovered evidence that had been buried.
